PLANNING COMMISSION and COUNCIL MEETING PUBLIC HEARING

Notice is hereby given that the Planning Commission and the Council of the City of McLoud, Oklahoma, will conduct a public hearing on a **PRELIMINARY SITE PLAT APPROVAL** for **FIREKEEPERS RV Resort, LLC** of McLoud, Oklahoma, on the following tract of land within the city limits of McLoud:

**E/2 OF NW/4 of Section 33, T11N, R2E, of the Indian Meridian, Pottawatomie County, Oklahoma, less and except:**
